

Dr. Gemma Lligadas i González

I am currently a Lecturer in Law at Universitat Ramón Llull in Barcelona, a Visiting Research Scholar at the Law Faculty of the Universität Hamburg (in the Area of European and International Law), a Global Governance Fellow at IBEI and a Human Rights Fellow at the Centre for Human Rights Erlangen-Nuremberg (starting in September 2024).

I am an interdisciplinary scholar specialized in the legal structure of global governance and the global legal order emerging at the intersection of domestic, transnational and international law. I am particularly interested in exploring the transformative dynamics and structural nature of the global legal order, understood as a multilayered legal system: in an increasingly globalized world, the domestic and international regulative levels are as interwoven as the politics behind them.

Drawing from the insights of my previous work, my current research agenda is designed to provide an all-encompassing theory on the political and legal structure of the global legal order, and the global reach of courts' transformative powers concerning the multilevel policymaking required by global events such as international crises. Hence, my academic and professional expertise is in Legal Theory, Public International Law, Comparative Constitutional Law, Global Constitutionalism and International Relations.

EMPLOYMENT HISTORY:

Since 2011, I have been a "**Profesora Asociada**" (Lecturer) at Universitat Ramón Llull (URL) and I have worked as an **Academic Coordinator** and **Academic Collaborator** at ESADE-Law School (ESADE-Law School is an academic institution within URL). In this capacity, I have designed and taught several courses (Legal Theory; Philosophy of Law; Fundamental Rights; Legal Deliberative Skills; International Organizations; Institutions & Decision-making; Introduction to International Relations; and Research Methods), most of them yearly, related to both Law and International Relations across different degrees (Law; Law & Business; Law & Global Governance; Bachelor in Global Governance, Economics and Legal Order). I have taught more than 1000 hours and I have also supervised 8 "Final Degree Dissertations".

I am also a **Temporary Full-time Global Governance Fellow** at IBEI (Institut Barcelona d'Estudis Internacionals) until July 2024. At IBEI, I teach **Global Public Policy** and **Politics of International Organizations** as a Global Governance Fellow. In this capacity, I also supervise several Master's theses at the crossroads of International Law and International Relations.

I have also organized several interdisciplinary seminars ("Brexit, chronicle of an announced good-bye"; and "New forms of juvenile delinquency with special attention to the phenomenon of Jihadism in Europe") and handled very diverse administrative tasks as an Academic Coordinator, providing teaching and administrative support to other colleagues and to the university when necessary. For example, I was in charge of managing the institutional relationship of ESADE Law School with the Inter-American Development Bank (IDB) within the framework of a course devoted to **International Development**. The course provided students with a theoretical and practical approach to the design and management of international development projects. To this end, students relied on the electronic resources provided by the IDB in order to plan the management of real-life projects presented by NGOs and other private entities collaborating with the university. My task was to supervise the academic coherence of the course, to coordinate the different instructors teaching the course and to handle the institutional interactions between ESADE, the IDB, and the other organizations involved in the practical cases of the course. I have also been the Academic Coordinator of the Research Skills Diploma and all activities related to Academic Debate (I hold a successful record and substantial experience in the field of public speaking as a debater, coach and organizer of academic debating tournaments and events) at ESADE Law School.

Previous to this professional experience as an academic scholar, I completed multiple internships in several international law firms and in very diverse branches of law: I worked in the area of Labor Law at Uría Menéndez, Corporate and Trust Law at Cuatrecasas Gonçalves Pereira, Criminal Law at Roca Junyent Abogados, and IP and Banking Law at Clifford Chance, both in Barcelona and London. I was also a Judge of Peace in Viladecans, and I was a trainee in the in-house legal service of the Hospital Clínic de Barcelona and in the European Parliament.
